A memorandum of understanding made this day 10th June, 2009

between


THE ENGLISH AND FOREIGN LANGUAGES UNIVERSITY, Hyderabad – 500605, Andhra Pradesh, INDIA (hereafter referred to as 'EFL-U')

and

UNIVERSITÉ EUROPEENNE DE BRETAGNE, France (hereafter referred to as 'UEB')

Clause I: Partnership

EFL-U, Hyderabad, India and UEB, France, on behalf of its member institutions, agree to enter into a formal collaborative agreement based on a foundation of trust for the mutual benefit and development of the two institutions and the promotion of international understanding and goodwill.

Clause II: Objectives

EFL-U, Hyderabad and EUB, France, intend to establish cooperation in the areas of faculty and student exchange, and towards the development of joint modules for study programmes. In furtherance of this aim, EFL-U and UEB, France, agree to collaborate for the purpose of fostering research through study visits, disseminating scholarship, and engaging in joint research projects. This co-operation may extend over all areas of scholarship covered by the two institutions.

Specific

EFL-U will collaborate with UEB, France, in two major areas:

1. e-Master programme: UEB will assist EFL-U in the preparation of modules for the e-Master programme that is to be launched by EFL-U.
2. Preparatory course in French: EFL-U will conduct a Preparatory Course (First Year) in French at its campus with the help of the Department of French Studies for students who after reaching the appropriate level of French shall then be eligible for admission to the course of their choice, like medicine, engineering, computers and others at a member university of the consortium UEB.

CLAUSE III: Mechanisms

The implementation of the project based on this agreement shall be separately negotiated and determined by both universities through mutual consultation. Separate memoranda of agreement shall be negotiated and signed for the implementation thereof.

The co-operation between EFL-U, India, and UEB, France, may be achieved in a variety of ways such as lectures and seminars, holding workshops and conferences, the provision of research facilities and academic hospitality, publication projects and training programmes.

CLAUSE IV: Funding

Individual projects for collaboration will be subject to separate negotiation and agreement and will be dependent upon available funding. EFL-U, India, and UEB, France, will each seek appropriate funding to support the purposes of this Agreement, and they will coordinate their endeavors wherever possible. Nothing shall diminish the full autonomy of either institution, nor will any constraints or financial obligations be imposed by either upon the other in carrying out the agreement.

CLAUSE V: Period of Agreement


The agreement shall have an initial duration of five years and shall be reviewed annually. This agreement is subject to revision or renewal by mutual agreement. It is also understood that either institution may terminate the agreement at any time, although such action will only be taken after mutual consultation at least six months prior to the effective date of termination in order to avoid any possible inconvenience to all parties.

Early termination of the MoU will not alter the responsibilities of the parties to carry out the terms of the Agreement with respect to the modules whose preparation has been undertaken and the students who have already been admitted to the preparatory course in French.

This agreement is effective when the representatives of both institutions have signed and dated the document.
